The *Adela Serra Ty Memorial Medical Center*, through HFEP CY 2019 & Hospital Income CY 2019 intends to apply the sum of **Package 1- Ten Million Pesos Only (PHP 10,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract of **Procurement of Equipment for Histopathology Section. Package 2- Ten Million Pesos Only** being the Approved Budget for the Contract (ABC) to payments under the contract of **Procurement of Digital Mobile X-ray (Full Digital Radiography) System. Package 3- One Million Eight Hundred Thousand Pesos Only** being the Approved Budget for the Contract (ABC) to payments under the contract of **Procurement of Uninterruptible Power Supply & Power Conditioner (50kVA/40kW 3 Phase Battery Back-up) with Installation**. Bids received in excess of the ABC shall be automatically rejected at bid opening
2. The *Adela Serra Ty Memorial Medical Center* now invites bids for **Package 1- Procurement of Equipment for Histopathology Section. Package 2- Procurement of Digital Mobile X-ray (Full Digital Radiography) System. Package 3- Procurement of Uninterruptible Power Supply & Power Conditioner (50kVA/40kW 3 Phase Battery Back-up) with Installation**. Delivery of the Goods required is **30-60 working days**. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.



4. Interested bidders may obtain further information from **Adela Serra Ty Memorial Medical Center** and inspect the Bidding Documents at the address given below during **8:00am to 12:00; 1:00 to 5:00pm, Monday thru Friday.**
5. A complete set of Bidding Documents may be purchased by interested Bidders on **[August 14, 2019 – September 3, 2019]** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount for **Package 1- Five Thousand Pesos Only (Php 5,000.00). Package 2- Five Thousand Pesos Only (Php 5,000.00). Package 3- Two Thousand Pesos Only (Php 2,000.00).**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Adela Serra Ty Memorial Medical Center** will hold a Pre-Bid Conference on **[10:00am; August 22, 2019]** at **AVR, 3rd floor, OPD Building, ASTMMC, Tandag City**, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **[10:00AM, September 3, 2019]**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**;
Bid opening shall be on **[10:01am; September 3, 2019]** **AVR, 3rd floor, OPD Building, ASTMMC, Tandag City.** Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The **Adela Serra Ty Memorial Medical Center** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
