### INVITATION TO BID FOR

Procurement of Industrial Washing Machine Including Installation, Testing & Commissioning w/ Electrical, Plumbing & Civil Works

- 1. The Adela Serra Ty Memorial Medical Center, through Hospital Income CY 2018 intends to apply the sum of Four Million Pesos Only (Php 4,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract of Procurement of Industrial Washing Machine including Installation, Testing & Commissioning w/ Electrical, Plumbing & Civil Works. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Adela Serra Ty Memorial Medical Center now invites bids for Procurement of Industrial Washing Machine including Installation, Testing & Commissioning w/ Electrical, Plumbing & Civil Works. Delivery of the Goods required is 30-60 Working Days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- Interested bidders may obtain further information from Adela Serra Ty Memorial Medical Center and inspect the Bidding Documents at the address given below during 8:00am to 12:00; 1:00 to 5:00pm, Monday thru Friday.
