## INVITATION TO BID FOR Procurement of Industrial Washing Machine Including Installation, Testing & Commissioning w/ Electrical, Plumbing & Civil Works

1. The **Adela Serra Ty Memorial Medical Center**, through **Hospital Income CY 2018** intends to apply the sum of **Four Million Pesos Only (Php 4,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract of **Procurement of Industrial Washing Machine including Installation, Testing & Commissioning w/ Electrical, Plumbing & Civil Works**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Adela Serra Ty Memorial Medical Center** now invites bids for **Procurement of Industrial Washing Machine including Installation, Testing & Commissioning w/ Electrical, Plumbing & Civil Works**. Delivery of the Goods required is **30-60 Working Days**. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from **Adela Serra Ty Memorial Medical Center** and inspect the Bidding Documents at the address given below during **8:00am to 12:00; 1:00 to 5:00pm, Monday thru Friday**.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **[August 15, 2019 – September 4, 2019]** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (Php 5,000.00)**.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
