Invitation to Bid for the Provision of Rain Water Tank Collector for Hospital Building Including Stone Masonry for Slope Protection CW-2021-003

1. The **Adela Serra Ty Memorial Medical Center**, through the **Internally Generated Funds 2017** intends to apply the sum of **Three Million Pesos Only [Php 3,000,000.00]** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Provision of Rain Water Tank Collector for Hospital Building Including Stone Masonry for Slope Protection** with Project Identification Number **CW-2021-003**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Adela Serra Ty Memorial Medical Center** now invites bids for the above Procurement Project. Completion of the Works is required **300 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Adela Serra Ty Memorial Medical Center** and inspect the Bidding Documents at the address given below from **8:00am to 5:00pm, Monday thru Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **June 22- July 12, 2021** from given address. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **Five Thousand Pesos Only [Php 5,000.00]**.
6. The **Adela Serra Ty Memorial Medical Center** will hold a Pre-Bid Conference¹ on **June 30, 2021; 10:00am** at **AVR, 3rd Floor, OPD Bldg, ASTMMC, Tandag City** and or through video conferencing or webcasting *via meet.google.com/rex-mvgrp-gwb* which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **10:00am; July 12, 2021**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **10:00am; July 12, 2021** at **AVR, 3rd Floor, OPD Bldg, ASTMMC, Tandag**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity and or may attend through video conferencing or webcasting *via meet.google.com/pej-xhon-wmj*.

The **Adela Serra Ty Memorial Medical Center** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
