## **INVITATION TO BID**

# **FOR THE Procurement of Blood Bank Reagents and Supplies**

### **IB NO. 2021-07-05 (28)**

1. The **Adela Serra Ty Memorial Medical Center**, using a **multi-year** for a duration of **(3) Three** year Framework Agreement, intends to apply the sum of **Nine Million Seven Hundred Forty Seven Thousand Seven Hundred Five Pesos Only [Php 9,747,705.00]** being the ABC to payments under the contract for **Procurement of Blood Bank Reagents and Supplies**. Bids received in excess of the total cost per item or per lot shall be automatically rejected.
2. The **Adela Serra Ty Memorial Medical Center** now invites bids for **Procurement of Blood Bank Reagents and Supplies**. Delivery of the Goods **after issuance of a Call-Off or any date determined by the PE**. Bidders should have completed, within **5 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Adela Serra Ty Memorial Medical Center** and inspect the Bidding Documents at the address given below during **8:00am to 5:00pm, Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 15 – July 5, 2021** from the given address below. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **Ten Thousand Pesos Only [Php 10,000.00]**.

6. The **Adela Serra Ty Memorial Medical Center** will hold a Pre-Bid Conference<sup>1</sup> on **June 23, 2021; 9:00 am** at **AVR, 3<sup>rd</sup> Floor, OPD Bldg, ASTMMC, Tandag City** and or through video conferencing or webcasting via [meet.google.com/goh-djui-fun](https://meet.google.com/goh-djui-fun) which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **9:00am; July 5, 2021**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

Bid opening shall be on **9:00am; July 5, 2021** at the given address below and or through video conferencing or webcasting via [meet.google.com/nac-zwnu-umx](https://meet.google.com/nac-zwnu-umx) Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Adela Serra Ty Memorial Medical Center** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
