INVITATION TO BID FOR PROCUREMENT OF MEDICAL OXYGEN IB No. 2021-06-23 (22)

1. The **Adela Serra Ty Memorial Medical Center**, using a Multi-Year for a duration of three (3) year Framework Agreement, intends to apply the sum of **Ten Million Pesos (Php 10,000,000.00)**; being the ABC to payments under the contract for *[Procurement of Medical Oxygen/ IB No. 2021-06-23 (22)]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Adela Serra Ty Memorial Medical Center** now invites bids for *Procurement of Medical Oxygen - IB No. 2021-06-23 (22)*. Delivery of the Goods is required within *1-2 calendar days* after issuance of a **Call-Off** or *any date determined by the PE*. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
 - b. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from **Adela Serra Ty Memorial Medical Center** and inspect the Bidding Documents at the address given below during **8:00am to 12:00pm and 1:00pm to 5:00pm Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 5-23, 2021** from the given address and ASTMMC Website *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of [Ten Thousand Pesos Only (Php 10,000.00)]*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in *the manner whether it will be presented in person, by facsimile, or through electronic means.*}]

6. The ***Adela Serra Ty Memorial Medical Center*** will hold a Pre-Bid Conference¹ on 11:00 am ***June 11, 2021*** at at[BAC office, 2nd Floor, OPD Building, ASTMMC, Tandag City]and/or through video conferencing or webcasting via *google meet* (<LINK: meet.google.com/pxt-wtpz-nsw>), which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before ***[10:30am; June 23, 2021]***. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on ***[10:31am; June 23, 2021]*** at the given address below and/or via *googlemeet* (<LINK: meet.google.com/geh-nctu-qmn>). Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The ***[Adela Serra Ty Memorial Medical Center]*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
