APPROVING THE AWARD OF CONTRACT FOR THE CONSTRUCTION OF MALASAKIT CENTER LEVEL III





PRELIMINARY EXAMINATION OF BIDS

WHEREAS, Open Competitive Bidding for the Procurement of ASTMMC Infrastructure Project: Construction of Malasakit Center Level III was conducted in accordance with the Republic Act 9184 (RA 9184) and its Revised Implementing Rules and Regulations;

WHEREAS, the Submission and opening of Bids took place as scheduled on 19th day of May 2021, 9:00 a.m., at AVR, 3rd Floor, OPD Building, ASTMMC, Capitol Hills, Tandag City;

WHEREAS, Only five (5) prospective bidders were able to procure the bidding documents, namely:

1. Joan Construction
2. ADSE Enterprises
3. Aguero Construction
4. RJ Construction and Supply
5. Juncynth Construction and General Services

WHEREAS, the first envelope containing the Technical Components were opened. The presence, completeness and correctness of the required documents were checked and verified by the HBAC in the presence of the prospective bidder representative. Out of five (5) prospective bidders who submitted their bid proposals only three (3) bidders were declared eligible namely:

1. Aguero Construction
2. RJ Construction and Supply
3. Juncynth Construction and General Services

WHEREAS, Joan Construction, was rated failed due to its non-compliant of their Net Financial Contracting Capacity, thus the submitted NFCC was not Notarize;

WHEREAS, ADSE Enterprises, was rated failed due to its non-compliant on SLCC, thus the submitted Single Largest Completed Contract did not establish on the required value;

WHEREAS, the second envelope, containing the Financial Components was opened. The presence, completeness and correctness of the entire document was checked and verified by the HBAC. The Three (3) eligible bidders were rated "PASSED", subsequently their bid proposal were red publicly and posted in the Abstract of Bids, to wit:




